DRIVING DIRECTIONS

From Southern Westchester County via Hutchinson River Parkway or I-95 - Take the Hutchinson River Parkway North or I-95 North to I-287 West to Exit 8. Follow Westchester Avenue. Make a left onto Bloomingdale Road. Take Bloomingdale Road straight & at the 4th traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From Southern Westchester County via Saw Mill River Parkway - Take Saw Mill Parkway North to Exit 20, I-287, the Cross-Westchester Expressway, to Exit 8W Bloomingdale Road. Make a left onto Bloomingdale Road & at the 3rd traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From New York City via the Henry Hudson Parkway and the Saw Mill Parkway - Take the Henry Hudson Parkway North to Saw Mill River Parkway North to I-287 East to Exit 8W. Make a left onto Bloomingdale Road & at the 3rd traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From Northern Westchester County via Rt .84/Rt. 684 - Take Route 84 to I-684 South to I-287 West to Exit 8. Follow Westchester Avenue. Make a left onto Bloomingdale Road. Take Bloomingdale Road straight & at the 4th traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From Northern Westchester County via The Taconic State Parkway - Take the Taconic State Parkway South until it becomes the Sprain Brook Parkway. Go south to I-287 East (left exit to White Plains) to Exit 8W, Bloomingdale Road. Make a left onto Bloomingdale Road & at the 3rd traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From Connecticut via I-95 or Merritt Parkway - Take I-95 South or Merritt Parkway South to I-287 West to Exit 8. Follow Westchester Avenue. Make a left onto Bloomingdale Road. Take Bloomingdale Road straight & at the 3rd traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From New Jersey via New Jersey Turnpike - Take the New Jersey Turnpike to George Washington Bridge. Go over the bridge and follow the signs for the Henry Hudson Parkway North to Saw Mill River Parkway North to I-287 East to Exit 8W. Make a left onto Bloomingdale Road & at the 3rd traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From Long Island via Whitestone Bridge - Take the Whitestone Bridge to Hutchinson River Parkway North to Exit 26W, I-287 West to Exit 8. Follow Westchester Avenue. Make a left at Bloomingdale Road. Take Bloomingdale Road straight & at the 4th traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From New Jersey via Palisades Parkway - Take the Palisades Parkway North to I-87 (NYS Thruway). Cross Tappan Zee Bridge Go 1 mile to Exit 8 onto I-287 East to Exit 8W Bloomingdale Road. Make a left onto Bloomingdale Road & at the 3rd traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From Rockland County - Take I-87 (NYS Thruway) Southeast. Cross Tappan Zee Bridge. Go 1 mile to Exit 8 onto I-287 East to Exit 8W Bloomingdale Road. Make a left onto Bloomingdale Road & at the 3rd traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.

From Staten Island via the Garden State Parkway - Take the Garden State Parkway North to I-87 (NYS Thruway). Cross Tappan Zee Bridge. Go 1 mile to Exit 8 onto I-287 East to Exit 8W Bloomingdale Road. Make a left onto Bloomingdale Road & at the 3rd traffic light make a right into 120 Bloomingdale Road. We are located directly across from Bloomingdale's Department Store.
